Work on the choreography will begin only after full payment has been received and all necessary information (music, preferences, number of participants, etc.) has been provided.

Delivery

The choreography will be completed by the agreed deadline, provided that all required information has been received in time.

If essential information is submitted late, the completion date will be adjusted accordingly.

Access to Learning Videos and Support Period

The Client will receive personal access to the learning videos and course materials.

The Client is entitled to share access only with the participants included in this agreement (according to the agreed number of dancers) for the sole purpose of preparing for the event.

Sharing login details or course materials with persons outside the agreed participant group is strictly prohibited.

The Client agrees to keep the access data confidential and is responsible for ensuring that all participants within the group do not copy, distribute or share the learning materials with third parties.

The Client shall be responsible for any unauthorized distribution of access credentials or course materials within their area of responsibility.

Access to the learning videos and personal coaching remains available until **two months after the agreed event date**. After that period, access will be automatically deactivated.

Videos, photos and other files submitted by the Client or participants may be deleted after the support period for organizational and data protection reasons, unless legal retention obligations require otherwise.

An extension of the access period or coaching period may be arranged separately upon request.

Right of Withdrawal

The Client expressly requests that the Contractor begins work on the individually created digital service before the statutory withdrawal period has expired.

The Client acknowledges that the statutory right of withdrawal expires once work has begun and no later than when the first learning videos are made available, in accordance with applicable law.

Data Protection

All personal data, videos, photographs and other submitted files will be treated confidentially.

No data will be shared with third parties.

Submitted videos will be used exclusively for personal coaching and video corrections.

Photos or videos will only be published for promotional purposes with the Client's prior express consent.

Copyright and Intellectual Property

All choreographies, learning videos, teaching materials and all other content remain the intellectual property of **Art of Dance – Mustafa Roshan**.

Upon full payment, the Client receives a non-transferable right to use the choreography and learning materials exclusively for the event specified in this agreement.

Any reproduction, distribution, publication or commercial use of the learning videos or teaching materials without prior written permission from the Contractor is prohibited.

Liability

The Contractor is liable only for the creation of the agreed choreography and the agreed teaching services.

The Contractor accepts no liability for the Client's learning progress, dance performance, event presentation or any mistakes made during the event.

The Client is solely responsible for practicing sufficiently and learning the choreography in time for the event.

Final Provisions

Any amendments or additions to this Service Agreement must be made in writing.

Should any provision of this agreement become invalid or unenforceable, the validity of the remaining provisions shall remain unaffected.

This agreement shall be governed by the laws of the Federal Republic of Germany.

If the Client is a merchant, a legal entity under public law or has no general place of jurisdiction in Germany, the place of jurisdiction shall, where legally permissible, be Bernau near Berlin, Germany. Mandatory statutory provisions regarding jurisdiction for consumers remain unaffected.
